## ENTRIES AND FEES

### NO. OF ALLOWABLE ENTRIES

The maximum number of entries is 70. Each class will have 5 substitutes.

The organizer reserves the right to adjust these numbers as required.

### ENTRY CRITERIA

- Hold a Sailplane Pilot Licence.
- Have met a FAI silver badge requirements and have competed in at least one gliding competition for the past 5 years.
- Have flown at least 70 hours on sailplanes as a pilot in command.

### ENTRY FEE

The entry fee covers all operational costs during the contest except towing fees.

If the entry fee is transferred to bank account by **31. 03. 2026** - the amount of 210,- EUR per participating glider. If a competitor pays the entry fee but does not participate in the competition and fails to notify the organizer by 19 April 2025, only half of the entry fee will be refunded.

The entry fee after 31. 03. 2026 is 230,- EUR per participating glider.

The entry fee for Juniors pilots is 160,- EUR per participating glider.

### LAUNCH FEE

One competition aerotow up to 750 m QFE in the designated release area is:

- 45,- EUR for club class
- 50,- EUR for combiclass

One competition take off of self-launching glider is 20,-EUR.

The organizer requires the payment of the 5 aerotows in advance, latest during the registration process on April 24<sup>th</sup> 2026.

Pre-paid and unrealized aerotows fees will be refunded in full amount.

## COMPETITION CLASSES

fatraglide26 will be held in the below listed classes. The class will be open when at least 10 participants of class will perform a competition launch on the first competition day.

If there are not enough pilots, they will be moved and scored together with another similar class.

### CLUB

CZIL index list will be used. Water ballast is forbidden.

---

### COMBI 15M +

CZIL index list will be used. Water ballast is allowed.

The organiser reserves the right to open a 15 m class (FAI class standard and 15 m) if there is a sufficient number of contestants for opening such class.

---

### COMBI 18M +

CZIL index list will be used. Water ballast is allowed.

his class will include gliders in the FAI 18 m and Open classes.

## ACCOMODATION

---

### CAMP AT THE AIRFIELD

The camping fee is 20,- EUR/ person/ night. Camping fee for each additional person (older than 12 years) is 10,-EUR per night. The price is inclusive of the connection to the power supply from the electricity power box.

---

### AIRFIELD HOSTEL

If you are interested in booking an accommodation at airfield hostel, please contact the Aeroclub Martin. The fee per one night in a hostel is set to 20,- EUR/ person/ night.

**Payment purpose:** „fatraglide26 – pilot’s first and last name and the glider’s registration. When paying for the campsite, enter a capital K, the number of persons, and the number of nights. When paying for tows, enter V and the number of tows.

*(fatraglide26 peter nagy OM5555 K 2 9 V 5 = peter nagy OM5555 is paying for 2 persons, 9 nights in the campsite, and 5 aerotows.)”*

## INSURANCE

### THIRD-PARTY INSURANCE

Coverage of liability insurance for third party damage must cover the entire duration of the competition and the value of coverage must be in accordance with applicable regulations.

Documentation proving the insurance shall be made available to the organizer in Slovak or English language.

### PERSONAL MEDICAL INSURANCE

Personal medical insurance (covering accidents and sickness, including any hospital costs and transportation back to country of residence) is required for all pilots and team members.

## MANDATORY EQUIPMENT

During the competition, the glider must be equipped with:

- GNSS Flight Recorder (FR) having IGC approval,
- Anchors (if the glider will stayout),
- FLARM system.

All instruments, PDA, GPS navigators etc. must be firmly mounted in the glider in such a way that the pilot’s vision is not affected.

FR calibration certificates are not required. However, to be considered by the Scorer, any calibration certificate presented must be current according to SC3 2.4.6.

The organizer recommends the use of the “cabin-flasher” anti-collision system.

## PILOT DECLARATION

The competitor is fully responsible for all personal and glider documentation and its validity. The organizer of the contest is not responsible for the incorrectly mentioned/ stated or invalid data within the pilot or sailplane documentation and shall in no event be liable for any consequences resulting from such deficiency.

Having the first competition take off, a competitor declares the understanding of the rules and local procedures for this competition.
